Tuition fees for the September 2016 intake amount to 45,000€.

Fee Payment Schedule

If offered a place on the Global MBA program, you will be given a deadline by which you should secure your seat by paying a non-refundable deposit (or first installment of the program fees) totaling €5,000.

Estimated Living Expenses in France

A survey of ESSEC students shows that a single participant can expect to incur the following basic expenses during the twelve month program. Allow an increase of approximately 25% if you are coming with your partner.
